Community Grants: The intention of this program is to build on existing programs and infrastructure in order to create more sustainable networks of collaboration across systems and sectors, ultimately resulting in enhancing the effectiveness of FASD prevention, intervention and support activities. 2011 has been the most productive and innovative year to date since the inception of this program. Not only have 19 new grants been funded, but new community partners have been engaged that will be long-term champions for FASD prevention and intervention. The current round of Community Grants sites have an incredible statewide reach, providing service to over 30 counties and 3 tribal reservations in Minnesota. This includes 9 Maternal Alcohol Use Screening grants, 4 Identifying FASD in Primary Care Community grants, and 6 Community Support Grants.

Intervention and Family Support: MOFAS volunteers, grantees and staff members have trained parents about their children's disability, provided family retreats, and young adult programming. Additional activities include Family Resources Coordinators across the state, A Virtual Family Center housed on the MOFAS website for families to connect, an updated, easier-to-use Resource Directory of providers for families, and specific programming for families living with chemical dependency issues through collaboration with the MN Department of Human Services.

Public Awareness: To help make FASD more widely understood, MOFAS supported several statewide awareness activities aimed at educating the general public and specific groups of people on the dangers of drinking during pregnancy. An extensive multi-media Public Awareness campaign was continued, aiming at care providers who work with pregnant women. Added to this campaign were messages aimed at women in their child-bearing years with the 049 message -- zero alcohol for nine months of pregnancy.
