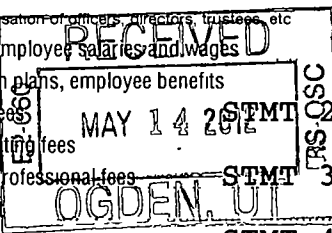

FORM AND CONTENT OF APPLICATIONS

SUCH REQUESTS MADE BY ORGANIZATIONS SHOULD BE IN WRITING AND MUST INCLUDE INFORMATION REGARDING THE BACKGROUND AND TAX-EXEMPT STATUS OF THE ORGANIZATION, A DESCRIPTION OF THE PURPOSE OF THE REQUEST, AND A FINANCIAL STATEMENT OF THE REQUESTING ORGANIZATION. ORGANIZATIONS APPLYING FOR A SUBSTANTIAL GRANT SHOULD PLAN TO MAKE A PRESENTATION TO THE DIRECTORS OF THE FOUNDATION. ORGANIZATIONS SHOULD FIRST CONTACT THE FOUNDATION TO OBTAIN THE STANDARD GRANT APPLICATION FORM. THE FORMAL APPLICATION PROCEDURE MAY BE WAIVED IN THE DISCRETION OF THE FOUNDATION DIRECTORS IN THE CASE OF THE APPLICATIONS FOR SMALL (LESS THAN \$2500) GRANTS; PROVIDED HOWEVER, THAT THE GRANT IS SPENT SOLELY FOR THE PURPOSE FOR WHICH IT IS MADE. APPLICATIONS ARE NOT ACCEPTED FROM INDIVIDUALS.

APPLICATIONS FOR GRANTS MAY BE SUBMITTED AT ANY TIME. APPLICANTS ARE PROMPTLY NOTIFIED THAT THEIR APPLICATIONS HAVE BEEN APPROVED OR REJECTED,

RESTRICTIONS AND LIMITATIONS ON AWARDS

---

IN AWARDING GRANTS, THE FOUNDATION GIVES PREFERENCE TO CHARITABLE ORGANIZATIONS LOCATED IN THE VICINITY OF PELLA, IA OR WHICH CAN DEMONSTRATE THAT THE PROPOSED GRANT WILL FURTHER THE IDEALS OF THE PELLA COMMUNITY. MOST GRANTS ARE FOR CHARITABLE PURPOSES BUT, TO THE EXTENT THAT FUNDS ARE AVAILABLE, GRANTS MAY BE MADE FOR OTHER PURPOSES, AND TO ORGANIZATIONS IN OTHER PARTS OF THE STATE OF IOWA. FEW GRANTS WILL BE MADE TO ORGANIZATIONS IN OTHER STATES, AND SUCH APPLICATIONS ARE NOT PREFERRED. THERE ARE NO SPECIFIC LIMITATIONS ON THE SIZE OF THE GRANTS THAT WILL BE AWARDED OTHER THAN JUSTIFICATION OF NEED. SCHOLARSHIPS ARE AWARDED TO ELIGIBLE STUDENTS OF VERMEER MFG CO EMPLOYEES, BASED UPON THE PERCENTAGE TEST IN REV.PROC. 76-47 SECTION 4.08 WHICH WAS APPROVED BY THE IRS. SELECTIONS ARE DONE BY AN INDEPENDENT PANEL.
