WHEREAS, a Resolution amending the declaration of trust was adopted October 18, 2003, changing the name of the organization to the Maquoketa Area Community Foundation; and

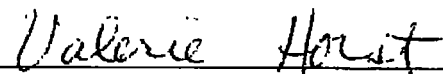
WHEREAS, the Distribution Committee has determined that it would be beneficial to the organization to change the name of the organization to "Community Foundation of Jackson County."

NOW, THEREFORE, BE IT RESOLVED by the Distribution Committee as follows:

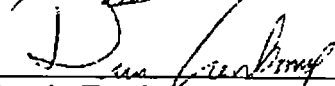
