Isuroon Project is a culturally appropriate education, communication, and advocacy organization for Somali women and health care providers. Founded in 2010, the agency operates on the principle that Somali culture emphasizes different values about medicine, health, and illness than Western medical traditions. Somali women's perceptions and understanding of the origin and meaning of wellness, illness, and recovery can be major factors in the effectiveness of the health care process. The ultimate goal of Isuroon is to provide Somali women with educational and informational resources to ensure that their cultural and spiritual traditions effectively interact with Western medical practices.

Isuroon Project uses a bottom-up community driven communication strategy that provides information about Somali women's needs, values, perceptions and opinions. This community focus helps the organization to select and tailor all of the programs and policies to meet the specific needs of Somali women and their families.

MISSION-Isuroon envisions a world in which there is more widespread knowledge among Somali women and their families about health issues, cultural beliefs, Somali women's health concerns, and a widespread adoption of good health practices throughout the community.

VISSION-Isuroon Project hosts an annual National Infertility Awareness event to educate and communicate about the topic of infertility. The event in April of 2012 will mark the third straight National Infertility Awareness event hosted by Isuroon. The organization also holds numerous support group meetings throughout the year. In 2011 there were 10 such meetings with an average attendance of 35 Somali women at each gathering. Just in 2011 alone, Isuroon Project employees met with roughly 550 Somali women to aid them in getting the culturally relevant educational information they needed. In addition to these accomplishments Isuroon has produced a number of successful Youtube videos, which serve as an alternative source of health information for Somali women. Two videos created in 2010 currently have over 25,000 views, while two more created in 2011 currently have over 27,000 views.
