The training provides women in sub-Saharan Africa with instruction and education in business skills for the benefit of the individual, her family and the community at large. MLF USA started this program in 2011.

MLF USA provided microloans to small groups of women who have completed the requisite business training. MLF's standard loan (average \$80 per person) is made to groups of 10-18 women. The records of MLF Malawi contain the names and addresses of any woman who receives microloans, independent references, amounts borrowed and repayments.
