Part III – Statement of Program Accomplishments

1.) Capacity Building

During its continuing effort to engage the citizens of Missouri, the staff at Missouri Citizen Education Fund (hereafter, MCEF) began to develop relationships with small business owners, spokespersons, ally organizations and community leaders in target areas around the state who are affected by issues surrounding the critical issues of the day.

Expenses -- \$21,040

2.) Leadership development

MCEF continued its successful campaign to recruit volunteers and activists to assist in engaging the public about public policy. The recruitment of leaders among the impoverished and underrepresented citizens of Missouri was emphasized here.

MCEF continues to identify opportunities to educate and train Missourians on what health care reform implementation means but has shifted its focus to training advocates to take leadership in this work. MCEF worked with allies to host two "Health Care Leaders" meetings with individuals who worked hard on passage and were wondering what was next, hosted debrief calls for activists to get their feedback on the work to date and talk about potential next steps and developed a skills building training with partners and experts to empower and develop our leaders in the collaborative work on health care moving forward.

Expenses - \$14,026

3.) Communications and Outreach

MCEF used its organizational resources and topical knowledge to conduct trainings with state and local community leaders, volunteers, and opinion leaders on how to effectively reach out on specific and critical policy issues. MCEF used its considerable resources among the state's media outlets to submit letters to editors, op-eds and media actions and events on critical issues of public policy. MCEF received significant media coverage as a result of this work

MCEF has also worked to recruit and submit letters to the editor across the state from individuals who can tell their story or publicly validate a position as a grassroots leader in strategic policy fights or educational opportunities as they arise. MCEF has also co released reports with Health Care for America Now (HCAN) and FamiliesUSA to provide timely analysis and relevant information about the impact policy proposals would have on Missourians.

MCEF continues to regularly check in and engage in calls and planning with other coalitions doing health care work in Missouri. This configuration has looked different depending on the

critical issue at hand, but engagement on this level has increased the effectiveness of our work and provided new tools among the partners as each others strengths are better understood.

Expenses - \$17,534

4.) Issue Education

MCEF educated Missourians on pressing public policy issues impacting our state. In 2011, much of our work focused on health care issues MCEF gave presentations on the Affordable Care Act. MCEF works with partners and allies on strategies that address the revenue crisis in Missouri. Activities include rallies, letters to the editors, press releases and educational outreach.

Expenses - \$17,534

Total Program Expenses - \$70,134
