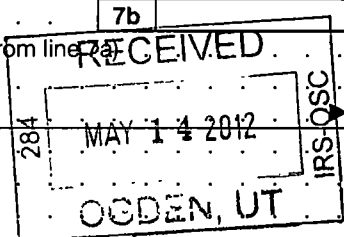

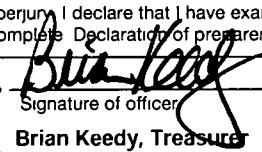

Statewide Elected Prosecutors conference provided training and education to Missouri's Elected Prosecutors. Cost included conference facilities, attendees meals and course materials.
