The mission of the St. Louis County Library is to provide the resources and services to enrich minds, enhance lives and expand perspectives. The Library Foundation is committed to keeping our public library system strong and vibrant, thereby ensuring a brighter, more enlightened future.

Creating unique and comfortable spaces within library branches that are dedicated for the use of teens and children is a strategic objective for the Library. The Foundation helped facilitate the creation of a children's area and completed teen areas at four branches during the year.

4b (Code:) (Expenses \$ 39,542 including grants of \$ 6,000) (Revenue \$)
Promoting reading and literacy within the community is a primary function of the Foundation. The Gift of Reading program encourages at risk preschoolers to read at home and in the library. It provides free new books once per month to children attending storytimes at eight branches. During 2011, 3,500 books were distributed. A donation of 1,400 books was made to a free clinic for children who have no health insurance. Free new hockey books were provided to participants in the Blues youth hockey camp. In 2011, the Foundation provided 3,475 children ages 0-2 with early literacy activities through the Baby Reading Club which encourages parents and caregivers to read to their babies. The Foundation also provided sponsorship of the Adult Reading Club, which had 10,919 participants and the Summer Reading Club for children and teens, which had 40,506 participants.

The Foundation further promotes reading by hosting free events with noted authors and sponsors the following author event series:
The Friends Series features readings, discussions, and book signings with authors of wide popular appeal and hosted 23 author events with an attendance of 4,000 this year. The Buzz Westfall Favorite Author Series hosts authors of compelling books about politics, history, current affairs and sports. Six authors were welcomed during 2011 with an attendance of 2,000. The Pacemaker Author Series features authors of compelling works on business, education, leadership and philanthropy. Three authors drew audiences of 300 people. The Reading Garden Event Series features author events and family concerts for children and young adult audiences. In 2011, 17 events were held with attendance of more than 4,000.
Read St. Louis is a community-wide initiative developed by the three major library districts of the St. Louis metropolitan area. Each year this program showcases six books for a variety of ages and reading interests and hosts author events with each of the selected authors. This program reaches over 800,000 library card holders at 49 library branches.
