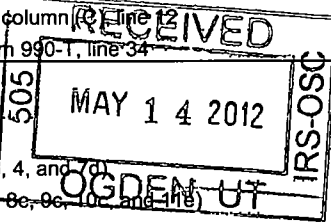

The Foundation has developed a program to monitor & report on water quality in the entire upper White River basin region. No systematic & comprehensive assessment of this sort has been done previously and this project is intended to provide information to the general public in response to the question, "How is the water?". The Foundation has contracted with the U.S. Geological Survey and Missouri State University for the field work and analysis of water quality and in October 2008, the first "Status of the Watershed" report was issued. During 2009 - 2011 the Foundation continued this project with their now annual status of the watershed report interpreting both levels of water quality during the year as well as longer term trends. This work continues in 2012 but we have decided to go with

Our new 2011 "program service" would be the MO Department of Natural Resources State Revolving Fund Grant to help property owners with the cost to remediate their failing septic system. The project provides up to \$10,000 per site to property owners in a 50-50 cost share to repair or replace failing septic systems that are now polluting our waters. The project is in partnership with the MO Department of Natural Resources, the MO Department of Conservation and Table Rock Lake Water Quality, Inc.

During 2010 and 2011, the Foundation published a weekly email newsletter distributed to over 900 subscribers dealing with water quality issues in the UpperWhite River Basin watershed. In addition, our Foundation's website was enhanced to provide access to water quality information to the general public, regulators and legislators. In 2011, we secured funding to publish 8,000 copies of a 54 page booklet entitled "Living with Land and Water in the Ozarks" that we handout. In 2011 our Board also voted to approve an Outreach Initiative that has 3 objectives: 1. Provide 5 - \$1,000 grants to other water quality groups for their projects; 2. Sponsor other water quality groups events such as cleanups and public education; 3. Attend public events and have a display booth where we handout information and
