YOUTHBRIDGE COMMUNITY FOUNDATION WAS ORIGINALLY ESTABLISHED AS GENERAL PROTESTANT CHILDREN'S HOME AND WAS FOUNDED IN 1877 TO PROVIDE A BRIDGE FROM CRISIS TO POSITIVE CHANGE FOR YOUTH AND FAMILIES. THE ORGANIZATION IS COMMITTED TO THE DELIVERY OF QUALITY SERVICES AND TREATMENT THAT EMPOWERS YOUTH AND FAMILIES TOWARD DEVELOPMENT OF HEALTHY RELATIONSHIPS, RESILIENCE AND SELF-SUFFICIENCY. BEGINNING IN 2004, YOUTHBRIDGE COMMUNITY FOUNDATION CHANGED ITS FOCUS TO INVESTING IN NEW ORGANIZATIONS SERVING CHILDREN WITH THE INTENT THAT THESE INDEPENDENT ORGANIZATIONS WOULD BECOME FULLY SELF-SUFFICIENT WITHIN FIVE YEARS.
