The FAWCO Foundation awards Development Grants to projects nominated by FAWCO member clubs. Recipients are Chosen after completing a thorough application process and all nominated projects undergo a vigorous review. The recipients are selected based on a vote by the FAWCO member clubs are outlined in THE FAWCO Foundation Administrative Guidelines.

FAWCO, The FAWCO Foundation and its member clubs selected water as its target project. This project is a unique opportunity for FAWCO member clubs and FAUSA members to work together towards the goal of clean water worldwide.

In addition, to raising awareness about the importance of clean water worldwide the clubs are now specifically fund raising for "Wells for Clean Water", Cambodia. FAWCO clubs are pooling their efforts to contribute together to a UN Millennium Goal.
