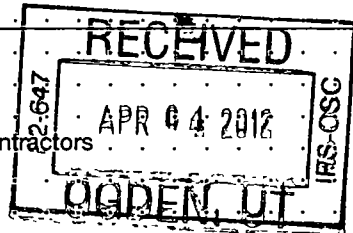

1- TRACY AVIARY BIRD SHOW - THIS PROGRAM BROUGHT THE TRACY AVIARY BIRD SHOW PROGRAM TO SANPETE COUNTY FOR THE FIRST TIME, THEY PRESENTED TWO SHOWS WITH STANDING ROOM ONLY CROWDS AT EACH SHOW, MORE THAN FILLING THE 300 CHAIRS SET UP. MORE THAN 600 PEOPLE, MOSTLY SCHOOL AGED CHILDREN, ATTENDED. OUR COST FOR THE PROGRAM WAS \$430 AND THERE WAS NO CHARGE FOR A HENDING.

2- MORMON MIRACLE PAGEANT FUND RAISING - DURING THE NINE DAYS OF THIS EVENT AND A SINGLE DAY AT THE MOUNTAIN 4<sup>TH</sup> OF JULY CELEBRATION, THE EXECUTIVE DIRECTOR AND SEVERAL VOLUNTEERS DID FACE PAINTING AS A FUND RAISER. THE PROJECT GROSSED \$802.30, \$300 IN WAGES WERE PAID TO THE EXECUTIVE DIRECTOR FOR HIS TIME.

4- MADSEN ELK RANCH FIELD TRIP - HELD AT A COMMERCIAL ELK RANCH, THIS EVENT TAUGHT OVER 300 ELEMENTARY SCHOOL STUDENTS THE DIFFERENCE BETWEEN ANTLERS AND HORNS AND HOW THEY GROW, HOW THEY ARE USED, AND HOW THE BENEFIT ANIMALS. \$132.50 IN WAGES WERE PAID TO THE EXECUTIVE DIRECTOR FOR HIS TIME.
