Creative Pinellas, Inc. was incorporated in June 2011 to fulfill the role of the Local Arts Agency (LAA) for Pinellas county Florida.

During 2011 activities were conducted by a volunteer, uncompensated board of directors to organize Creative Pinellas - develop the plan, bylaws, fill positions on the board and get approval from the Pinellas county commissioners to appoint Creative Pinellas the LAA.

After finally getting appointed the LAA by the Pinellas Board of County Commissioners we negotiated the contract with Pinellas county to secure funds from the county. This contract was approved in November and funds finally authorized in mid-December to fund

Creative Pinellas work. The only expense in 2011 was the IRS user fee to apply for tax exempt status.

The only financial transactions for 2011 were receipt of the \$300,000 grant from the county and payment of IRS user fee.

There were no paid employees during 2011. Thus, few items in our 990 apply for 2011.

This 990 was reviewed with the Board at the March Board meeting.
