A primary focus in 2011 was the once-per-decade redistricting process.

Education Regarding Important Issues. The Alliance for a Better UTAH [often in collaboration with its affiliate, the ABU Education Fund] used billboards, radio ads, OpEds, Letters to the Editor, earned media and radio appearances to bring attention to, and educate the public about, current issues of importance. In 2011, these issues included immigration reform, budget issues, open government, charity, unemployment, gun issues, redistricting, public lands, tax matters, public education, local control and states rights.
