Ronald Shurts is the founder, President and major contributor to the 2011 Ronald L. Shurts Foundation. Mr. Shurts has been in a litigious divorce since mid-2011. In conjunction with the divorce, there was some form of settlement agreement where his former spouse was awarded a substantial amount of money.

She successfully had a garnishment executed from all of Mr. Shurts' personal and business accounts, including the Foundation's checking account. No notice was given of the garnishment being served. On December 29, 2011, the Foundation's bank immediately removed \$40,500 from the checking account.

At the time the garnishment was served on the Foundation's bank, Mr. Shurts was out of town and could not respond immediately. The bank would not speak to anyone else regarding the matter.

When Mr. Shurts returned, he engaged legal counsel and the \$40,500 was returned to the checking account on January 3, 2012.

Due to the unusual nature of the garnishment, the fact that Mr. Shurts had no control over the actions of the bank and that the funds were restored to the checking account six days later, this event is not being reported as an act of self-dealing pursuant to IRC Sec 4941 subject to an excise tax.
