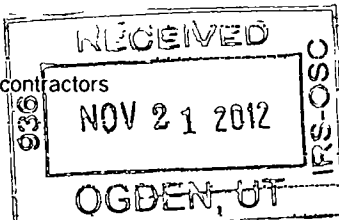

The Corporation's primary exempt purpose is to research, investigate, analyze and implement ways to provide the health and wellness benefits of the philosophy of Sri K. Pattabhi Jois to primarily underserved students from preschool through high school, to provide the results of such investigation, research, analysis and implementation to the general public, and to encourage the general public to consider, discuss, and comment upon such results and to make other proposals for such consideration, discussion and comment. The primary activity of the Corporation will be to provide grants to public schools (K-12) and other community-based nonprofit organizations across the United States to support the schools' and other organizations' programs to improve the health and wellbeing of their students, with a focus on introducing the underprivileged students the benefits of yoga. Funds may be used to hire a qualified yoga instructor who would co-teach PE/Health classes throughout the year on a schedule developed by the school. Funds may also be used to provide short-term enrichment programs.

The Corporation will provide support in the form of grants to public schools and other community nonprofit organizations which promote the health and well-being of underprivileged students with the goal of increasing academic achievement. No grants will be made to specific individuals.

In 2011, K.P. Jois USA Foundation, Inc. made a grant in the amount of \$40,000 to the Ivy Hawn Charter School (Section 501(c)(3) organization) at 555 S. Lakeview Drive, Lake Helen, Florida to provide yoga instructions to its students. In addition, \$8,820 was paid to Yoga Instructors as program related expenses. (See Part III, Line 28(a))
