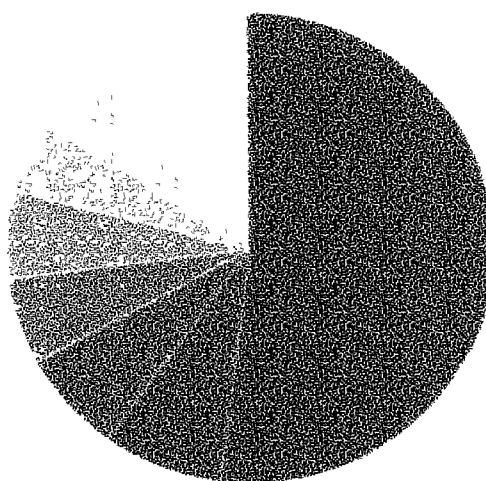
2-1-1 COMMUNITY SERVICES HOTLINE

In September of 2010, Nebraska was the 30th state to achieve border-to-border 2-1-1 coverage. Individuals in all 93 Nebraska counties can now dial 2-1-1 to easily access local community services 24 hours, seven days a week. Trained operators help callers assess their needs and direct them to the appropriate resource ranging from basic needs to public information.

In 2011, 2-1-1 operators helped over 926 callers in Hall, Hamilton, Howard and Merrick counties locate services and find solutions to their problems.

COMMUNITY IMPACT GRANTS & FAMILYWISE PROGRAM

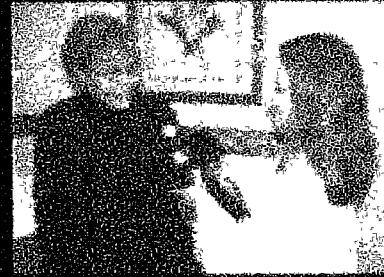
Each year, a portion of Heartland United Way's campaign funds are made available to non-profits in our four-county area. Community Impact Grants provide funds for projects that innovatively address education, income and health issues. In July of 2011, \$72,041

was awarded to ten organizations to fund income, education and health centered programs.

The FamilyWise prescription discount program offers discounts of up to 40% for prescription drugs not covered by insurance. The card is accepted nation-

wide by most pharmacies and is available for free from Heartland United Way. In 2011, United Way's partnership with FamilyWise increased the program's presence in our community, enabling 4,983 people to receive savings of over \$77,545.11.

PROGRAM IMPACT IN 2011



In 2011, the United Way agencies provided opportunities for youth and adults to learn to be successful in school and life. Big Brothers Big Sisters MOM2MOM program matched volunteer community mentors with pregnant or parenting teens with 90% reporting they were on track to graduate. Adult Education had 62 students complete the requirements and pass the tests to earn their GED enabling them to pursue a career and become self-sustaining adults. Outreach programs were developed by the Boy Scouts and Girl Scouts to provide afterschool scouting experiences in target schools. Girl Scouts reported that 80% of the 112 girls developed a strong sense of self. Boy Scouts reported that 95% of the 151 boys developed good physical fitness habits. Among children birth to 4 enrolled in the YMCA's Child Development program, 88% increased their physical skills and 79% increased cognitive skills. Over 50 people completed citizenship classes through the Multicultural Coalition with 5 earning their citizenship.

FINANCIAL

There are a growing number of people in our community who are struggling to make ends meet. United Way agencies provide financial assistance and education to help families through a crisis and then develop a plan for the future. At CNCS and Hope Harbor, 602 individuals were taught financial skills. The combined debt that was paid among the participants of both programs was \$191,494 and collectively they were able to put \$105,559 into savings accounts. CNCS also reported that \$53,609 was paid in taxes by their program participants. 30 individuals were granted legal status with assistance from Lutheran Family Services enabling them to become gainfully employed. Hope Harbor provided 13,365 bed nights in their shelters with 59% of the transitional shelter residents gaining employment during their stay.

HEALTH

In 2011, Heartland United Way Agencies provided health and wellness programs to encourage healthy lifestyles. The Third City Community Clinic saw 3,594 patients who had no other access to health or dental care. At the clinic 226 sports physicals were completed so kids could participate in athletic activities. 1,479 people received counseling in a time of need by calling the Crisis Line at the Crisis Center. While at Hope Harbor 99 mental health sessions were provided to homeless shelter residents to increase coping skills and overcome barriers. The YWCA empowered 41 girls to speak freely about social issues they face to prevent unhealthy, risky behaviors. Court Appointed Special Advocates provided a voice in court for 108 abused and neglected children.

- 220 youth, matched with adult mentors, all reported an improved attitude toward school and 86% reported improvement in grades (Big Brothers Big Sisters)
- 1265 students demonstrated increased knowledge about dating violence & bullying (Crisis Center)
- 75 volunteers were trained to respond to disasters and were responsive to 29 fires that had 82 people needing emergency aid (American Red Cross)
- 21 participants completed a 6 week financial education course at Howard Elementary School (Heartland United Way & Wells Fargo)
- 82 domestic violence victims became self-sufficient working on budgeting skills and securing employment (Crisis Center)
- 63 children received dental care by the Ronald McDonald Dental Caremobile (Third City Community Clinic)
- 30 pregnant or parenting teens were educated on raising healthy children (Big Brothers Big Sisters)
- 3,807 youth and adults were provided alcohol and drug abuse prevention education (CNCAA)
