**Fun 5 Afterschool Fitness and Nutrition Program:** Kaho'omikl manages the statewide Fun 5 program, with activities in 173 schools on all Hawaiian Islands (except Ni'ihau), with more than 18,000 elementary school children participating. Each site has on-site group leaders that work directly with the children each day - Kahoomiki provides twice-yearly hands-on training in physical activities and nutrition education for these group leaders (nearly 1,000 statewide); provides operational manuals to facilitate the training activities; provides playground equipment and nutrition education equipment to each site; provides evaluative follow-up to site coordinators; provides information about afterschool activities in Hawaii and elsewhere to all group leaders and site coordinators; serves as liaison with other community groups regarding the value and operation of afterschool programs. Program is almost entirely funded by program service grants from others. Success is measured by number of schools/sites that participate, number of elementary students enrolled, and number of times per week that each site implements the physical activity and nutrition programs of Fun 5. In 2011, the state instituted a 45 percent increase in the cost of participating in afterschool programs, which caused a drop in participation from around 21,000 in 2010. Number of site coordinators and group leaders trained remained relatively constant, and number of sites implementing Fun 5 increased by three.

**4b** (Code: ) (Expenses \$ 32,941 including grants of \$ 0 ) (Revenue \$ 33,425 )

**Aloha State Games:** Kaho'omikl organizes and manages the activities of this statewide multi-sport event in the Islands (prior to 2009, the Aloha State Games were part of Hawaii Pacific Sports, a now defunct 501(c)3 organization). The games are organized to provide Hawaii residents and visitors of all ages with opportunities to participate in numerous sports activities (some 21 different sports in 2011). The games take place each June and July, and are organized primarily with volunteer assistance. Primary source of funds is participant registration fees; small "sponsorship" grants also provided some funds in 2011. Approximately 2,200 people participated in the 2011 Aloha State Games, all of whom are amateurs. Success is largely measured by participation - when the games were founded in 1990, with adequate state and corporate funding, more than 8,000 Hawaii residents participated. An effort is underway by Kahoomiki to build participation back to comparable levels. The games enjoy a solid positive reputation in the Islands.

**Hawaii Senior Olympics:** Kaho'omikl organizes and manages this statewide multi-sport event in the Islands for people who are at least 50 years of age on December 31 of that year. Pre-seniors (40+) also are invited to participate in some sports. For 2011, approximately 280 people participated in 13 different sports conducted during November and December. Primary source of funds is participant registration fees. The senior Olympics goal is to provide seniors with opportunities to be involved in physical activities that contribute to healthy living. They also serve as a qualifying site for the National Senior Games, which has a similar purpose. These Hawaii games are the only such multi-sport activity organized specifically for amateur seniors in the Islands, and provide additional incentive for seniors to remain physically active. Success measurement is largely based on participation - 2011 was not a qualifying year for the national games, and participation was down significantly from the normal 350 or so participants. The games first organized in 1999.

**4d – Kelki Fun Run – In 2011, Kahoomiki was a community partner of the Kelki Great Aloha Run which raised over \$25,000 for 65 public and private elementary and preschools to support their physical activity and nutrition education programs. GAR also contributed \$2,500 to Kahoomiki to be used as start-up funds for 2012, when Kahoomiki assumed the primary coordinating role for this established event. Focus is on getting children and their families to recognize the value of, and participatory fun in, being physically active. Event includes a grant program for schools as noted above – all registration funds go back to the schools of the entrants. Expenses are covered by sponsors.**

**CHK Project – In early spring, Kahoomiki received a \$40,000 grant from the Campaign for Healthy Kids to investigate and monitor public policy on childhood obesity issues, particularly relating to compliance with state health standards at the elementary level. Kahoomiki served as the fiscal sponsor of this project in support of the Hawaii 5-2-1-0 public education campaign and Farm-to-School legislation, and compiled a Legislative Leadership Information Gathering report to complete the grant requirements. A companion grant from the Hawaii Community Foundation also provided support of these efforts at public education and policy development aimed at obesity prevention by enabling Kahoomiki to continue work of the discontinued Hawaii Nutrition and Physical Activities Coalition. Grants received: \$71,000. Expenses: \$29,732**
