Our mission is to ensure the educational, social and economic development of all persons and work to eliminate the large poverty rate and economic disparity.

 Bellmead Economic Development Corporation Support Services. We provide business development support services for the business and potential businesses of the City of Bellmead.

4c (Code:) (Expenses \$ including grants of \$) (Revenue \$)
 Cen-Tex African American Chamber of Commerce established the Center of Business Excellence with a \$200,000 grant from the U. S. Small Business Administration. After reorganizing in 2007, the organization went from a budget of \$14000 and one employee to three employees and a \$200000 budget. Because of this accomplishment, in 2010 CTAACC was named Chamber of the Year by the National Black Chamber of Commerce. One member, reported winning over \$150,000 in contracts and hired 5 additional employees with our support.
