Any expense is directly related to the event. Event expenses consist mainly of insurance, permits, rentals, boxes for toys, and any used for minor donation gifts (t-shirts, donuts, water).

A large portion of the event expense goes to insurance and porta potties. Grants listed here. \$372,000.
