Operated community outreach offices to provide information to the public about blindness and how to help blind people and to locate blind persons in need of assistance.

Provided assistance to blind people to attend seminars and workshops designed to assist the blind in learning methods and techniques of organizing local groups of blind people for self-help and in learning about library services, rehabilitation services, new technology, aids, devices, and other resources and materials.

Developed, produced, or distributed in print, Braille, and/or recorded media materials relating to blindness.
