CLIENT SERVICES INCLUDE PREGNANCY TESTS, PARENTING CLASSES, MATERIAL SUPPORT, POST-ABORTION RECOVERY, MARRIAGE AND FAMILY THERAPY, AND MEN'S PARENTING CLASSES. IN 2011 WE PROVIDED 1,151 PREGNANCY TESTS, 337 CLIENTS RECEIVED PARENTING CLASSES, GAVE MATERIAL SUPPORT VALUED AT OVER \$60,240 AWAY TO CLIENTS AND THEIR BABIES, PROVIDED POST ABORTION RECOVERY FOR 15 CLIENTS, MET WITH CLIENTS 871 TIMES FOR MARRIAGE AND FAMILY THERAPY APPOINTMENTS AND PROVIDED SUPPORT FOR MEN IN ALL OF THESE SITUATIONS
