"STARBASE or BUST" Teaching innovation grant for \$8,000. Provided transportation necessary to attend STARBASE Kansas City. Students increased their knowledge and skills in the areas of science, technology, engineering, and mathematics through the the Department of Defense sponsored STARBASE program

"Watch DOGS" (Dads of Great Students) Teaching innovation grant for \$5,000. This innovative program, sponsored by the National Center for Fathering, focuses on the prevention of violence in schools by using the positive influence of fathers and father figures to be active role models for students. It provides students, many who do not have a positive role model in their live, an opportunity to interact with male role models in a supervised, safe school environment.

"Bridging the Summer Reading Gap" Teaching innovation grant for \$3,500 This program provides six books to each Lawson Elementary Student to take home and read over the summer months. Many of the students are from SES homes and have few or no books at home, nor do they frequent the library

"Connecting with History Surviving the Holocaust" Teaching innovation grant for \$3,094 Purchased four classroom sets of "Surviving the Holocaust Stan Kijowski's Journey in a Wicked World" and brought Mr. Kijowski to Leavenworth High School to to speak to the students.

"Graphing Calculator Rental Program" Teaching innovation grant for \$5,000. In order to offer students access to hand-held calculators with graphing technology at home as well as at school, this program covers the purchase and rental of TI-84 graphing calculators

"Access to Reading" Teaching innovation grant for \$2,500. This project purchased personalized assistance tools. The tools come with all the materials to work with ten students at any given time. This program will allow all students to read a variety of materials independently and also helps with increasing knowledge and comprehension.

Kiwanis Reading Award \$10,000. This program recognizes the "most improved readers" in 4th, 6th and 8th grades. Winning students are honored at the Foundation Breakfast where they receive certificates. Their school libraries receive \$1,000 to purchase books; each book is labeled on the inside cover with the honored student's name. Their names are also engraved on a plaque that hangs in the entryway of their school. This is a great encouragement to students who might not be the best readers, but the most improved

First National Bank Horizon History Journey \$10,000: The purpose of this program is to ensure that when our students graduate they will have had an opportunity to learn from experiential learning trips to area museums that support Kansas and US history curriculums. Students 4th through high school may visit the Carroll Mansion, the Carousel Museum, First City Museum and the Richard Allen Cultural Center in Leavenworth; the Buffalo Soldier Memorial and Frontier Army Museum at Fort Leavenworth; the Arabia Steamboat Museum, Harry S. Truman Presidential Library, and Liberty WWI Memorial in Kansas City; and the Kansas History Museum, the State Capitol.
