In 2011, the Foundation published 24 articles in the Kansas Farm Bureau Leader Letter that is disseminated to over 36,000 individuals. These articles include topics, such as: Ag Child Laws; Contracts; Water Law; Oil & Gas Leases; Horizontal Drilling; Social Security; Succession Planning; Spray Drift; and Rails-to-Trails.

In addition, the Foundation has succeeded as an advocate and educator by speaking to audiences across the State of Kansas on topical issues surrounding agriculture. For instance, staff spoke at 40 different events averaging 55 participants at each event for a total of 2,200 individuals. Topics included: oil and gas leases; wind energy; agricultural law update; agri-tourism; farm and hunting leases; contracts; transmission line easements; urban sprawl; fence laws; zoning regulations, nuisance; Clean Air Act, Clean Water Act; and Endangered Species Act to name a few.

Further, the Foundation leads the effort by producing timely papers that impact the economic and legal viability of agriculture. Issues include: Transmission Line Easements; Oil & Gas Leases; and Severed Mineral Rights. Finally, the Foundation works with such organizations such as the Kansas Bar Association and hosts Agricultural Law Seminars for attorneys from around the State of Kansas. The hope is to educate rural, private practitioners and urban attorneys, along with policy-makers, business leaders, and academics with timely court cases, regulations and laws that
