IN ADDITION, 33,868 MEALS WERE SERVED, INCLUDING 5,440 TO "DROP-IN GUESTS" WHO WERE NOT STAYING AT THE CITY MISSION BUT CAME FOR MEALS. A TOTAL OF 870 TAKE HOME FOOD BASKETS WERE ALSO PROVIDED TO THESE DROP-IN GUESTS AND NON-RESIDENTS DURING 2011.
