Through grantmaking, we seek to improve the health and welfare of patients. The Foundation funded 5 research grants in 2011.

The NACDS Foundation provides crucial Scholarship programs to Pharmacy Schools and individual Pharmacy students throughout the United States. 124 Pharmacy Schools and 66 individual Pharmacy students were awarded scholarships this year. The pharmacy school awards are designated for the school's scholarship funds for students.

The Foundation also offers education programs and resources for pharmacists, pharmacy technicians, pharmacy students and the general public on public health issues.

4c (Code XXXX) (Expenses \$ 508,249. including grants of \$ 453,900.) (Revenue \$ 53,920.)

Charitable Outreach: The Foundation gives priority to those charitable organizations where medication adherence can have a positive impact on the health of patients. The largest share of our annual contributions budget is allocated to programs that address the health needs of patients, including patient, children's health, and community outreach initiatives. The Foundation donated or provided grants to 25 charitable organizations.
