Services included support of resident governance councils, identification and mentoring of resident volunteers, advocacy for residents with building management and Seward Towers Board of Directors and implementation of programs that build community within each building and promote integration of residents into a wider neighborhood.

Restorative Justice - As a voluntary alternative to court for youth offenders, the Seward Longfellow Restorative Justice Program seeks to repair harm by involving the victim, offender, and community in solutions that promote healing, accountability and reconciliation. IN 2011, 29 youth offenders and their families participated in this program. In addition, over 25 youth participated in Youth Peacing-Making Circles held twice a month at two different locations.
