The ASCAP Foundation scholarship programs seek to ensure that opportunities for the study of music and instruments, songwriting, music composition, the business of music and related areas are available to students at all levels by providing Scholarships and Fellowships to 62 recipients ranging from \$1,000 - \$12,000. The ASCAP Foundation provides awards to emerging composers and writers consisting of cash awards to 102 recipients of composer and / or lyricist programs. These awards range from \$200 - \$10,000. Of these 102 awards, 100 awards are \$5,000 or less and 2 awards are for \$10,000 each.

The ASCAP Foundation is dedicated to nurturing the music talent of tomorrow by developing and supporting educational programs that provide effective learning opportunities consistent with our mission to students of all ages. The ASCAP Foundation has provided funding to sponsor 38 Music Education and / or Music Development programs throughout the year with the goal of enhancing and promoting music education and providing the community with access to music. The 38 programs include 25 programs that have received \$5,000 or less and 13 programs that received more than \$5,000.

The ASCAP Foundation Talent Development programs provide aid and encouragement to music creators nationwide who are in various stages of their music careers including Workshops, (14); Commissions and / or Commissioning programs, (2) and Talent Development programs, (27). By providing professional opportunities to emerging composers, lyricist and songwriters the Foundation supports their careers and promotes their work.
