Over the past decade we have developed innovative math programs for primary (grades K-5) and middle school (grades 6-8) In 1999 we published "Bridges in Mathematics" Grade 2 and subsequently published Grade 1 in 2000, Grade K in 2001, Grade 3 in 2005, Grade 4 in 2006, and Grade 5 in 2007 Through 1998 we received significant funding from the National Science Foundation for the development of the above materials Since then we have been self-funded through the sale of these materials to school districts as well as individual teachers We have recently begun actively seeking another round of grant funding to help us develop the next generation of offerings We believe that simply publishing innovative programs is not enough Our experience, and a growing body of research, has shown us that teachers need support and training for successful implementation in the classroom We offer a variety of services from workshops to consulting to online resources Workshops are offered throughout the United States and usually carry graduate credit from Western Oregon University
