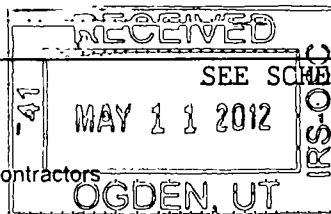

Part III:

1. The RoughRiders Foundation's purpose is to enhance the community we serve through charitable contributions, grants and programming initiatives by motivating and rewarding families and children in the area of education, good health and community service activities.

Three major programs:

1. Kids Night Out
2. Grants and Donations
3. RoughRiders Family Night

1. Kids Night Out

Kids Night Out allows local non-profit agencies the opportunity to host the children and families they serve, many who might never have the chance to experience a professional sporting event, at a Minor League Baseball game. Kids Night Out allows children to witness the results of hard work, dedication, and teamwork – qualities needed to excel in all aspects of life. This program takes place twice during the year, and serves over 1,200 underprivileged and underserved children from across North Texas.

2. Grants and Donations

The RoughRiders Foundation allocates a portion of its budget to grants and donations, which are awarded to numerous nonprofits throughout the year. The goal of this program is to assist organizations that help and support children and families, specifically in the area of education, good health and community service.

Organizations awarded \$1,000 grants must submit a grant application form and are considered for these donations on a rolling basis through July of each year. In 2011, the Foundation donated over \$13,000 to nonprofit organizations serving the community.

3. RoughRiders Family Night

Family Night allows the RoughRiders Foundation to recognize, support and provide awareness for one of its major community partners, Frisco Family Services, which is a local non-profit serving hundreds of families in the Frisco community. The program allows Frisco Family Services to host over 500 of its volunteers and the families it serves at Dr Pepper Ballpark, providing a unique experience that strengthens family relationships and creates lasting positive memories. In addition, the RoughRiders Foundation hosts a food drive at the ballpark during Family Night, donating thousands of items to the Frisco Family Services food pantry. This once-a-year program assists Frisco Family Services in recognizing its volunteers, provides a unique experience for families who are currently struggling, and allows for additional support and awareness from the Frisco community at large.
