

## NOTES TO FINANCIAL STATEMENTS

### **Note 1. Organization and Summary of Significant Accounting Policies**

#### **Organization:**

The Bayat Foundation, Inc. ("The Foundation") is dedicated to providing essential services to the people of Afghanistan. The Foundation is committed to building partnerships that enhance the Foundation's business resources in sponsorship and support to direct human aid, as Afghanistan rebuilds. Projects focusing on education, health, empowerment of women, human basic needs and preservation of the rich culture and heritage of Afghanistan are central to the Foundation's activities.

#### **Basis of Accounting:**

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

#### **Financial Statement Presentation:**

In accordance with generally accepted accounting principles, the Foundation is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets. In addition, the Foundation is required to present a statement of cash flows.

#### **Use of Estimates:**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

#### **Cash and Cash Equivalents:**

For purposes of the Statement of Cash Flows, the Foundation considers all highly liquid investments with an initial maturity of three months or less to be cash equivalents.

The Foundation's financial instruments that are exposed to concentration of credit risk consist primarily of cash and cash equivalents. The Foundation places its cash and cash equivalents with high credit quality institutions. At times such investments may be in excess of the Federal Deposit Insurance Corporation (FDIC) insurance limits.

## NOTES TO FINANCIAL STATEMENTS

### **Contributions:**

In accordance with generally accepted accounting principles, contributions received are recorded as unrestricted, temporarily restricted, or permanently restricted support, depending on the existence and/or nature of any donor restrictions. Support that is restricted by the donor is reported as an increase in unrestricted net assets if the restriction expires in the reporting in which the support is recognized. All other donor-restricted support is reported as an increase in temporarily or permanently restricted net assets, depending on the nature of the restriction. When a restriction expires (that is, when a stipulated time restriction ends or purpose restriction is accomplished), restricted net assets are reclassified to unrestricted net assets and reported in the Statement of Activities as net assets released from restrictions.

### **Contributed Services and Resources:**

During 2011, the Foundation received substantial contributions of time and resources from Bayat Family at no cost. Current year financial statements include an in-kind contribution for the use of office space and other related occupancy costs in the amount of \$11,484 provided by a related Bayat family-owned entity. This amount reflects the Foundation's recognition of the contribution and related expenses.

### **Functional Expenses:**

Expenses are charged to program or general and administrative expenses based on a combination of specific identification and allocation by management.

### **Tax Status:**

The Foundation was incorporated as a not-for-profit corporation under the laws of the State of New Jersey and is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code. The Foundation is exempt from federal and state income taxes on related income pursuant to Section 401(a) of the Internal Revenue Code and Chapter 2201.13 of the Florida Statutes, respectively.

The Foundation applies generally accepted accounting principles related to income tax uncertainties, which it adopted on January 1, 2009. The Foundation has determined that there were no unrecognized tax benefits for the year ended December 31, 2011. The Foundation files tax returns in the U.S. federal jurisdictions. Tax years that remain subject to examination by major tax jurisdictions are 2008 and forward.

## NOTES TO FINANCIAL STATEMENTS

### Note 1. (Continued)

#### **Subsequent Events:**

In preparing these financial statements, the Foundation has evaluated events and transactions for potential recognition or disclosure through the report date, the date the financial statements were available to be issued.

### Note 2. Related Party Transactions

During 2011, an organization owned by a member of the Board of Directors and the member's spouse, who is also a member of the Board of Directors, donated \$100,000 to the Foundation which is included in unrestricted contributions at December 31, 2011. These monies were designated by the Board of Directors for payment of the Foundation's administrative expenses in the current and future years. The Foundation also received donated services and resources from this related organization (See Note 1).

### Note 3. Temporarily Restricted Net Assets

Temporarily restricted net assets represent cash received primarily for program specific purposes. As of December 31, 2011, temporarily restricted net assets consisted of the following:

### Note 4. Net Assets Released

Net assets were released from restriction by incurring donor stipulated expenses of \$91,995 for the fiscal year ended December 31, 2011.

### **Note 5. Concentrations**

The Foundation grants substantial funding to a not-for-profit organization incorporated under the laws of Afghanistan to provide program services. The Foundation receives periodic, if not monthly, reports concerning the expenditures and the progress of the specific program being funded.

### **Note 6. Fair Value Measurements**

The Foundation applies generally accepted accounting principles for fair value measurements of financial assets and liabilities. These accounting principles defines fair values and establishes a hierarchy that prioritizes fair value measurements based on the types of inputs used for the various valuation techniques. The three levels of inputs used to measure fair value are as follows:

Level 1 - Values measured using quoted prices in active markets for identical investments.

Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.

Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The carrying amounts reflected in the statement of financial position for cash and cash equivalents and accrued expenses approximate fair value due to the relative terms and/or short maturity of these financial instruments.
