In 2011, the 44th edition had 746 pages which included information on 136 residency listings, 504 fellowships, and 8 post-sophomore listings. This book is available to the general public. ICPI maintains a website where the Directory information is available for free to the public.

A new addition of the Pathology as a Career in Medicine brochure was created and printed for distribution for all medical students in the United States. Print copies to the public are free. ICPI maintains a freely available version on its website.

ICPI Trainee Travel Awards

ICPI established this program to support trainee participation in scientific meetings organized by its member societies. The award is intended to offset the travel cost for attending the meeting. Awardees must currently be a trainee (medical student, graduate student, resident, fellow) member of one of the sponsoring societies or associate members of ICPI. In 2011, ICPI awarded 27 travel awards.

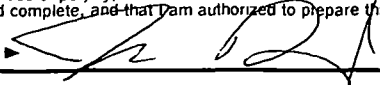
