The operation of the Halfway House is funded through the District of Columbia Department of Corrections and the Federal Bureau of Prisons. There are a maximum of 40 residents housed on any one day of the year. During 2011, a total of 196 men on parole or in work-release programs were serviced.

The major objectives of EFEC's Halfway House are:

1) to promote self-help programs to ex-offenders desiring to rehabilitate themselves to fully accept their rights and responsibilities as citizens; and
