Organization Summary

COMPTEL advances its members' interests through trade shows, networking, education, and policy advocacy before Congress, the Federal Communications Commission and the courts. 4a. Conventions & Expos

In 2011 COMPTEL marked its 30th anniversary, which we celebrated at the COMPTEL *PLUS* Spring 2011 Convention & EXPO in Las Vegas and during an April event at Union Station in Washington, D.C.

Numerous former and current COMPTEL chairmen, board members and staff joined COMPTEL in Las Vegas, where the anniversary celebration kicked off the opening night festivities on March 20 at the COMPTEL *PLUS* convention. The next day's general session featured a seven-minute video retrospective of the association's history, featuring a number of key individuals discussing the association's accomplishments over its 30-year history and the introduction of COMPTEL's new logo.

Spring 2011 – Las Vegas, Nevada

Key statistics from the Spring show include:

- 155 10' x 10' booths sold
- More than 1,075 attendees used the Business PLANner to schedule meetings in the EXPO hall and deal center, and participated in more than 500 meetings with prospective and current customers.
- 50 C-level executives, who attended the CEO Breakfast, which featured industry leaders as speakers/presenters
- Educational sessions included topics on cloud computing, intercarrier compensation, BTOP/BIP awards, federal contracting, Ethernet over copper, privacy, M&A, enterprise IP architectures, video and voice technologies, wireline and wireless, inside view of Congress, OSS, smart grid, and the future of IP networks
- EXPO hall featured additional education sessions, including a Speakers Corner with presentations from 10 companies and a theater hosted by the Metro Ethernet Forum (MEF)
- Half-day Wednesday workshop on "The State of Carrier-to-Carrier Wholesale Relationships," hosted by Kelley Drye & Warren LLP

Fall 2011 Show – Orlando, Florida

The keynote speaker was Erik Qualman, internationally recognized social media guru and author of "Socialnomics." During the opening session, COMPTEL also recognized outgoing Chairman Joe Ambersley for his decade of service to the association and its Board of Directors.

Key statistics from the Fall show include:

4b. Advocacy

COMPTEL’s policy team scored a number of prominent wins in the courts throughout 2011, and continued its strong and effective advocacy on key issues of concern to the competitive communications industry before federal and state regulators, and on Capitol Hill.

In the Courts

In two cases before the U.S. Supreme Court, COMPTEL won unanimous decisions.

Case 1 - FCC v. AT&T – stemmed from a Freedom of Information Act (FOIA) request filed by COMPTEL in 2005 seeking records from the FCC relating to an investigation into AT&T’s participation in the E-Rate program.

Case 2- Talk America Inc. v. Michigan Bell Telephone Company dba AT&T Michigan – the Supreme Court reversed a decision by the 6th Circuit, ruling that AT&T must lease entrance facilities used for interconnection purposes to other carriers at cost-based rates.

Other key competitive issues addressed by the courts included:

- *Forbearance*
- *Special Access*
- *AT&T/T-Mobile Merger*

At the FCC

A number of noteworthy issues have been addressed by the FCC this year, and COMPTEL has been actively involved in pursuing development of regulations that foster continued growth of competition in a variety of sectors of the industry. Those issues include:

On Capitol Hill

COMPTEL continues to be a go-to source for Congressional committees and staff seeking comment and input on key telecommunications issues. In 2011, we continued our efforts to educate new members of Congress and staff via meet and greets, and briefings on the competitive industry, featuring representatives from our member companies.

COMPTEL staff has been active on a number of other legislative initiatives that impact our members, as well, including:
