Grants also support DAV's Hospital Service Coordinator Program under which the volunteer drivers manage the transportation requests. Additionally, grants support DAV's National and State Department Service Programs providing representation for veterans and their families with benefits claims from the VA, Dept of Defense and other government agencies.

The Policy is reviewed no less than annually for the information and guidance of all such persons. Any new Officer, member of the Board of Directors, and new staff member is advised of the Policy upon undertaking the duties of their position. Each person annually signs a statement affirming receipt of a copy of the Policy, his/her understanding of the Policy, agreement to comply with the Policy, and verification that he/she has disclosed any potential conflicts of interest.
