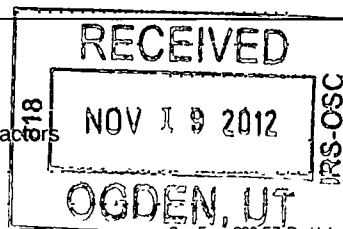

USAIM's mission is to broaden public awareness and mobilize private sector resources in support of domestic and international programs that provide assistance to migrants and refugees. USAIM concentrates its efforts on human trafficking, health (especially HIV/AIDS), emergency relief, and public information campaigns. USAIM does so primarily by supporting and promoting the work of the IOM, which is committed to the principle that humane and orderly migration benefits migrants and society.

**Ghana** - The objective of this project is to rescue, rehabilitate and reintegrate trafficked children who have been forced to perform forced labor in fishing communities on Lake Volta in Ghana. In 2011, 20 children were rescued and reintegrated into their communities; parents of all 20 children received micro-credit assistance; the 20 children were placed into schools; the children were continuously assessed, counseled, and monitored. Total Expenses: \$16,513.00, Grants: \$16,513.00

**Sudan** – With funding from Humanity United, IOM assured its presence in the Abyei Area of Sudan for the purposes of planning, coordinating, liaising and project implementing. An increased level of IOM presence in the months preceding the referendum facilitated the flow of information to key UN decision makers as well as increased the ability of agencies to respond to incidents in the region as they occur. Specifically, IOM continued to support the Government of National Unity (HAC) and Government of Southern Sudan (SSRRC) to monitor population movements; coordinated more effectively with RCSO and other UN agencies / NGOs on the ground in Abyei; aggregated all relevant sources of information on returns and settlements; quickly and effectively responded to large-scale movements and displacements.
