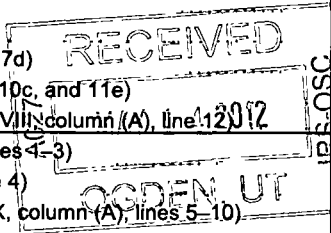

In 2011, DCCK recovered approximately 815,000 pounds of food, which was used to provide meals to Washington D.C.'s homeless shelters, transitional homes and close to 100 other partner social service agencies throughout the Washinton metropolitan area.

DC Public Schools - The Organization provides healthy breakfasts, lunches and suppers to seven public schools in Washington, D.C. This service aims to bring local, seasonable and sustainable cost-effective dining service to local schools that want to create a sustainable food model for their future. In addition, we are breaking the nutritional divide and introducing kids to healthy eating through scratch-cooked school meals prepared each day.

Fresh Start Catering and Contract Foods is a full-service, professional catering and contract foods company that employs graduates of DCCK's job training program and generates revenue for DCCK. With Fresh Start, graduates build on the skills they acquired in the Culinary Job Training program by focusing on advanced culinary skills, presentation techniques, and formal service that will enable them to obtain jobs in the competitive hospitality industry. This program supports DCCK's training program as well as serving for a model for what we believe corporate philanthropy can be.

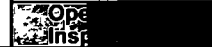
