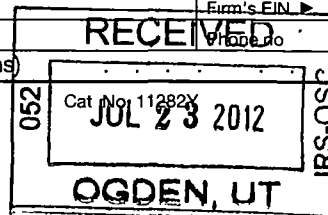

Operated a food security and vocational training program in the Bahn Refugee Camp, targetting primarily women refugees from the Ivory Coast. Trained 200 women in vocational skills including baking, hair dressing, tye dye & sewing. Provided seeds, tools and training to 1300 refugees in order to grow staple crops and vegetables on land adjacent to the refugee camp. Trained 400 women and men in adult literacy.

Emergency Education Program for Ivorian Refugees in Maryland County, Liberia

Enrolled 1600 youth in these programs, ages 2-18. Trained 16 teachers and 12 vocational education instructors.

Trained farmers in improved rice production and post-harvest processing. Introduced NERICA rice, an improved variety, for the first time to these communities.
