After viewing this presentation, guests receive spiritually educating CDs, DVDs, and bookmarks. All guests are encouraged to take a free magazine (illustrated with our exotic birds) and other free publications to assist in their study of the scriptures and to learn how to deal with the stresses of life. Various media outreaches are also available to assist in teaching how to cope with life in a positive manner.

In 2011, more than 100,000 guests visited the facility.
