


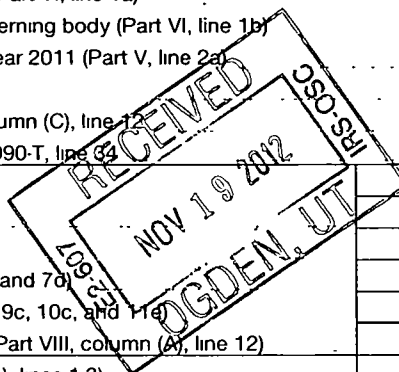

THE ARCHIVES SHOP, WHICH PROVIDES A STEADY SOURCE OF REVENUE FOR THE FOUNDATION, HAS PRODUCED A VARIETY OF PRODUCTS EXCLUSIVE TO THE NATIONAL ARCHIVES. DESPITE PERIODS OF DECREASED ATTENDANCE AND A CHALLENGING ECONOMIC CLIMATE, THE SHOP SURPASSED ITS BUDGETARY GOALS IN 2011. PLANS ARE BEING DEVELOPED TO RELOCATE AND EXPAND THE RETAIL SPACE. THE NEW SPACE IS EXPECTED TO OPEN IN LATE 2012.

EXHIBITS: THE EXTREMELY-WELL RECEIVED "DISCOVERING THE CIVIL WAR" EXHIBIT CLOSED IN APRIL, 2011. AS A TRAVELING EXHIBIT, IT OPENED AT THE HENRY FORD MUSEUM IN DEARBORN, MI, ON MAY 21ST TO EXTENSIVE PRAISE FROM THE PUBLIC AND PRESS. MORE THAN 20,000 PEOPLE WAITED IN LINE OVER A 36-HOUR TIMEFRAME TO SEE THE EMANCIPATION PROCLAMATION WHICH TRAVELED WITH THE EXHIBIT FOR A VERY BRIEF PERIOD. THE EXHIBIT CLOSED IN SEPTEMBER AND MOVED TO THE HOUSTON MUSEUM OF NATURAL SCIENCE IN HOUSTON, TX, WHERE IT OPENED IN OCTOBER 2011 TO MORE GREAT REVIEWS. INCLUDED IN THE \$23.6 MILLION CAPITAL CAMPAIGN, THE FOUNDATION'S PARTNERSHIP WITH THE NATIONAL ARCHIVES HAD DESIGNED AND BUILT A PERMANENT EXHIBITION GALLERY.
