



SELECTION IS NOT BASED SOLELY ON GRADES, BUT ALSO ON OVERALL ACADEMIC MERIT, COMMUNITY SERVICE, VALUES, AND ABILITY TO OVERCOME SERIOUS OBSTACLES.



**AMENDED AND RESTATED
CERTIFICATE OF INCORPORATION
OF
HISPANIC COLLEGE FUND**

(Pursuant to Sections 242 and 245 of the
General Corporation Law of the State of Delaware)

The Hispanic College Fund was originally incorporated pursuant to the Delaware General Corporation Law on November 25, 1992 under the name Hispanic Business College Fund, Inc.

**Article I
Name**

The name of this corporation is Hispanic College Fund (the "Corporation").

**Article II
Duration**

This Corporation shall have perpetual existence.

**Article III
Purpose**

- A. This Corporation is organized and shall be operated exclusively for religious, charitable, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), including, for such purposes, the making of distributions to organizations under Code Section 501(c)(3), (or the corresponding section of any future Federal Tax Code). More specifically, this Corporation is organized to solicit funds from corporate and individual contributors for the purpose of awarding scholarships to Hispanic and other students to further the cost of secondary and post-secondary education.
- B. This Corporation shall have all of the powers of a natural person, subject only to limitations imposed by these Articles, the Bylaws of this Corporation and applicable laws. Notwithstanding any such powers, or any other provision of these Articles, this Corporation shall not carry on any activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code, or (ii) by a corporation contributions to which are deductible under Section 170 (c)(2) of the Code (or corresponding Sections of any future Federal Tax Code).

- C. No substantial part of the activities of this Corporation shall involve itself in propaganda or otherwise attempt to influence legislation (except as otherwise provided in Section 501(h) of the Code), and the Corporation shall not participate in, or intervene in any political campaign (including the publication or distribution of statements) on behalf of any candidate for public office.
- D. This Corporation shall have and exercise all rights and powers conferred on non-profit corporations under the laws of the State of Delaware, or which hereafter may be conferred, in order to accomplish its purpose.

Notwithstanding any of the above statements of purpose and powers, no substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its directors, members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Code Section 501(c)(3) purposes set forth herein.

Article IV **Membership**

The membership of this Corporation shall consist of all of the members of the Board of Directors. This Corporation is not organized for profit and is not to have authority to issue capital stock.

Article V **Management of Corporate Affairs**

The powers of this Corporation shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors composed of five members and whose replacements shall thereafter be elected by the remaining members of the Board of Directors as provided in the By-Laws. The number of Directors may be increased or decreased from time to time as the Board of Directors may determine, however the number of Directors shall not be less than five (5).

Article VI **Dissolution**

This Corporation shall be dissolved and its affairs concluded by a vote of two-thirds (2/3) of the Board of Directors. All of the property and assets of this Corporation are and shall be irrevocably dedicated to the purposes set forth in Article III above, meeting the requirements for exemptions provided by Section 501(c)(3) of the Code. No part of said property or assets shall ever inure to the benefit of any director or officer or to the benefit of any private individual or entity. Upon dissolution, winding up or abandonment of the Corporation, provision for payment of all debts and liabilities of this Corporation shall be made to the extent assets available. If after payment of all such debts and liabilities there remains any Corporate assets, such assets shall be distributed to or for one or more exempt purposes within the meaning of Code Section 501(c)(3), or corresponding sections of any future Federal Tax Code, or shall be distributed to the Federal Government, or to a state or local government, or a public purpose.

Article VII
Rights of the Board of Directors

The majority vote of the Board of Directors shall be required to alter, amend, or repeal this Amended and Restated Certificate of Incorporation or to merge the Corporation.

Article VIII
Registered Office and Agent

The registered office of the Corporation shall be 2711 Centerville Road, Suite 400, City of Wilmington, County of New Castle, and the registered agent of the Corporation located at such office shall be Corporation Service Company.

This Amended and Restated Certificate of Incorporation has been approved by a majority of the members of the Board of Directors in accordance with the Bylaws and Section 242 of the Delaware General Corporation Law.
