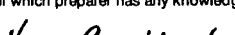

1. Kids2College (\$57,464.49)

Kids2College is The Fund's early-college awareness program. This six-session curriculum is taught within schools and community groups to middle school students and encourages them to start thinking about college. In 2011, The Fund:

- Continued to provide training to college-access partners nationwide
- Continued to offer its national core curriculum and online community to support program partners
- Reached roughly 52,500 students at 64 schools in partnership with 60 colleges and universities

2. Educational Materials (\$45,309.83)

In 2011, The Sallie Mae Fund distributed 20,000 free educational materials to help families plan and pay for college at events and online, including:

- 13,250 Mission Possible books, available in English and Spanish
- 5,000 "Top 10 Tips for College Admissions and Financial Aid" cards, available in multiple languages
- 1,550 copies of Saving for College Brochure, available in English and Spanish
- 200 Latino College Dollar Scholarship Directories

3. Saving, Planning and Paying for College Workshop Series (\$20,278.24)

Saving, Planning and Paying for College is a nationwide program sponsored by The Sallie Mae Fund that visits local communities to increase awareness among high school students and their parents that a higher education is accessible. In each community, this 30-90-minute workshop covers topics such as: the benefits of continuing an education beyond high school; the affordability of college through various types of financial aid available (i.e., grants, scholarships and loans); and resources available to help families prepare for the college-admissions process. One future college student at each workshop wins a \$500 scholarship toward the cost of a college education. During 2011, The Fund:

- Conducted 11 free Paying for College workshops
- Reached 1,435 students and parents
- Partnered with organizations and schools, such as Communities In Schools and Houston Independent School District, and co-hosted with six policymakers

4. Community Outreach (\$1,500.00)

The Sallie Mae Fund supports the communities where Sallie Mae employees live and work by encouraging a culture of community support and volunteerism. In 2011, The Fund supported a number of local efforts, as well as national programs with Reading Is Fundamental and the corporate-wide Dollars for Doers program.
