THE FOUNDATION EVALUATES UNCERTAINTY IN INCOME TAX POSITIONS BASED ON A MORE LIKELY THAN NOT RECOGNITION STANDARD, EFFECTIVE JANUARY 1, 2010. IF THAT THRESHOLD IS MET, THE TAX POSITION IS THEN MEASURED AT THE LARGEST AMOUNT THAT IS GREATER THAN 50% LIKELY OF BEING REALIZED UPON ULTIMATE SETTLEMENT. PRIOR TO JANUARY 1, 2010, THE FOUNDATION EVALUATED UNCERTAIN TAX POSITIONS SUCH THAT THE EFFECTS OF THE TAX POSITIONS WERE GENERALLY RECOGNIZED IN THE FINANCIAL STATEMENTS CONSISTENT WITH AMOUNTS REFLECTED IN THE RETURNS FILED, OR EXPECTED TO BE FILED, WITH TAXING AUTHORITIES.
