RESEARCH & GRANT PROGRAM FARA'S COMMITMENT TO FUNDING HIGH QUALITY RESEARCH PROJECTS THAT MOVE US CLOSER TO EFFECTIVE TREATMENTS CONTINUED AT AN ACCELERATED PACE IN 2011 IN TOTAL, FARA PROVIDED >\$2 5M IN RESEARCH GRANT AND CLINICAL RESEARCH INFRASTRUCTURE FUNDING OVER THE PAST YEAR, 29 NEW GRANT APPLICATIONS WERE SUBMITTED AND AFTER RIGOROUS PEER REVIEW, 13 WERE DETERMINED MERITORIOUS AND AWARDED FUNDING IN 2011 AND EARLY 2012 IN ADDITION, BASED ON EXCELLENT PROGRESS, CONTINUATION FUNDING WAS PROVIDED FOR 14 PROJECTS, FOR A TOTAL OF 27 GRANTS AWARDED - THESE FUNDED PROJECTS ADDRESS NUMEROUS IMPORTANT RESEARCH QUESTIONS THAT DIRECTLY TARGET FARA'S STRATEGIC RESEARCH INITIATIVES, INCLUDING IMPROVED FUNCTIONAL MEASURES AND BIOMARKERS FOR CLINICAL TRIALS, ADVANCES IN GENE AND CELL THERAPY APPROACHES, IMPROVED TOOLS FOR DRUG DISCOVERY, AND EVALUATION OF CANDIDATES TO ADVANCE TO THE TREATMENT PIPELINE SEVERAL ARE CO-FUNDED WITH OUR FRIEDREICH'S ATAXIA ADVOCACY GROUP PARTNERS, THIS COLLABORATIVE APPROACH BOTH INCREASES THE NUMBER OF AVAILABLE RESEARCH DOLLARS AND HELPS TO MINIMIZE DUPLICATION OF EFFORT OF NOTE, FA SHARES SIMILAR SYMPTOMS AND DISEASE MECHANISMS WITH OTHER DISEASES, BOTH RARE AND COMMON - PARTICULARLY PROMISING RESEARCH FUNDED BY FARA IS BEING DONE BY DR SID HECHT AT ARIZONA STATE UNIVERSITY HE IS SYNTHESIZING COMPOUNDS KNOWN AS MULTIFUNCTIONAL RADICAL QUENCHERS (MRQS) AND TESTING THEM IN FA CELL AND ANIMAL MODELS TO DETERMINE THEIR POTENTIAL AS TREATMENTS FOR FA MRQ COMPOUNDS ARE DESIGNED TO BLUNT MITOCHONDRIAL DEGRADATION RESULTING FROM OXIDATIVE STRESS AND TO AUGMENT ATP PRODUCTION IN PARTIALLY DYSFUNCTIONAL MITOCHONDRIA IN A RECENTLY PUBLISHED PAPER (ARCE ET AL, 2011, A STRATEGY FOR SUPPRESSING REDOX STRESS WITHIN MITOCHONDRIA, ACS MED CHEM LETT 2 608-613), DR HECHT AND HIS COLLEAGUES DEMONSTRATED THAT THEY HAD DEVELOPED AN MRQ THAT PROTECTS FA FIBROBLASTS FROM OXIDATIVE STRESS MORE EFFECTIVELY THAN EITHER IDEBENONE OR IDEBENOL THEY ARE CONTINUING TO DEVELOP AND EVALUATE MODIFIED MRQ COMPOUNDS TO IDENTIFY THOSE THAT ARE LIKELY TO BE THE MOST EFFECTIVE THERAPEUTIC AGENTS FOR FA - ANOTHER GRANT AWARD TARGETING DRUG DISCOVERY HAS GONE TO DR GINO CORTOPASSI AT THE UNIVERSITY OF CALIFORNIA, DAVIS DR CORTOPASSI HAS DEVELOPED AN APPROACH THAT TARGETS REPURPOSING OF DRUGS HE DEVELOPED ASSAY TO SCREEN DRUGS THAT HAVE ALREADY BEEN APPROVED FOR HUMAN USE IN OTHER DISEASES AND INDICATIONS AND IDENTIFY THOSE DRUGS THAT PROTECT THE FA PATIENT CELLS FROM DEATH THIS GRANT AWARD FOCUSES ON DETERMINING THE MECHANISMS OF ACTION, RELATIVE POTENCY, AND EFFICACY IN CELL AND ANIMAL MODELS OF THE SELECTED DRUGS IN PREPARATION FOR CLINICAL TESTING IN INDIVIDUALS WITH FA SUCH AN APPROACH TO REPURPOSING DRUGS OFFERS A POTENTIAL EXPEDITED COURSE TO CLINICAL TESTING BECAUSE MUCH IS ALREADY KNOWN ABOUT THESE DRUGS AS THEY HAVE ALREADY BEEN STUDIED IN OTHER DISEASES - IN ADDITION TO RESEARCH GRANTS FARA FUNDS THE ONGOING DEVELOPMENT OF VITAL CLINICAL RESEARCH INFRASTRUCTURE CLINICAL RESEARCH INFRASTRUCTURE REFERS TO THE RESOURCES NEEDED TO FACILITATE ANY TYPE OF RESEARCH, INCLUDING CLINICAL TRIALS, THAT INVOLVE PATIENTS THESE RESOURCES CAN INCLUDE THINGS LIKE - PATIENT REGISTRY A DATABASE THAT CAPTURES INFORMATION ON INDIVIDUALS WITH A SPECIFIC CONDITION - FARA PATIENT REGISTRY WWW.CUREFA.ORG/REGISTRY - NATURAL HISTORY STUDY LONGITUDINAL DATA (USUALLY ABOUT 10 YEARS) ON INDIVIDUALS WITH A DISEASE THAT DESCRIBES AND QUANTIFIES THE PROGRESSION OF THE DISEASE ALONG WITH THE SYMPTOMS AND MANIFESTATIONS OF THE DISEASE NATURAL HISTORY CAN SOMETIMES SERVE AS THE BASIS FROM WHICH MEASUREMENTS CAN BE MADE TO DETERMINE EFFECTS OF NEW TREATMENTS, DRUGS OR INTERVENTIONS - CLINICAL OUTCOME MEASURES FUNCTIONAL PERFORMANCE TESTS (E G , TIMED PEGBOARD OR WALK TESTS, VISION, HEARING OR SPEECH TESTS) THAT QUANTIFY HOW MUCH CHANGE TAKES PLACE IN A SPECIFIC AMOUNT OF TIME AND ARE USED IN CLINICAL TRIALS TO MEASURE WHETHER A DRUG IS ALTERING THE COURSE OF THE DISEASE - BIOREPOSITORY A REPOSITORY OR BANK OF STORED BIOLOGICAL MATERIALS SUCH AS BLOOD SAMPLES, DNA, ORGANS, AND TISSUES (SUCH AS SKIN, MUSCLE, HEART) THAT CAN BE USED FOR RESEARCH - COLLABORATIVE CLINICAL RESEARCH NETWORK IN FA (CCRN IN FA) AN INTERNATIONAL NETWORK OF 11 CLINICAL RESEARCH CENTERS THAT WORK TOGETHER TO ADVANCE TREATMENTS AND CLINICAL CARE FOR INDIVIDUALS WITH FRIEDREICH'S ATAXIA HAVING SUCH A NETWORK MEANS THAT THERE ARE TRAINED PHYSICIANS AND RESEARCH COORDINATORS READY TO DO CLINICAL RESEARCH STUDIES AND TRIALS ALSO, THIS NETWORK IS BACKED BY A DATA COORDINATION CENTER THAT FACILITATES ALL ASPECTS OF DATA COLLECTION, DATABASE MANAGEMENT, AND STATISTICAL ANALYSIS OF STUDY DATA TO LEARN MORE, VISIT WWW.CUREFA.ORG/NETWORK.HTML- THROUGH THE CCRN IN FA WE HAVE COLLECTED SIX YEARS OF NATURAL HISTORY DATA (ONGOING) IN MORE THAN 600 INDIVIDUALS WITH FA, VALIDATED CLINICAL OUTCOME MEASURES AND THE FARS SCALE, STUDIED SPEECH, VISION AND HEARING, LAUNCHED BIOMARKER STUDIES, ESTABLISHED DNA AND RNA REPOSITORIES, AND PROVIDED MANY BLOOD SAMPLES TO RESEARCHERS AROUND THE WORLD THE CCRN IN FA INVESTIGATORS HAVE BEEN INVOLVED IN MULTIPLE CLINICAL TRIALS INCLUDING A FEW THAT WERE DESIGNED AND CONDUCTED SOLELY THROUGH NETWORK SITES FARA CONTRIBUTED MORE THAN \$500,000 IN 2011 TO CLINICAL RESEARCH INFRASTRUCTURE IN DIRECT FUNDING TO THE CCRN IN FA CENTERS AND RELATED CLINICAL RESEARCH ACTIVITIES -
