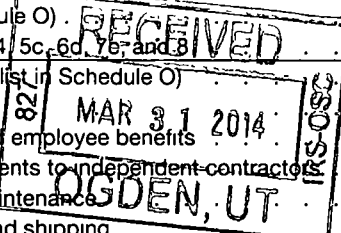

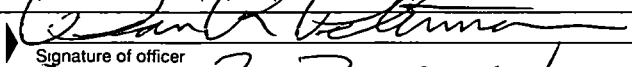

The Division of Industrial & Engineering Chemistry (I&EC) has a subdivision, The Separation Science and Technology Subdivision (SS&T).

The I&EC included the activity of the SS&T in its 2012 Form 990-EZ and related forms. The 990-EZ and related forms for 2011 are being amended to include the activity of the SS&T Subdivision. The SS&T activity included adding \$250 of Program Revenue, \$48 of interest income, \$4,747.32 of SS&T convention expense, and \$1,369 of miscellaneous expense. The convention expense for I&EC was reduced by \$11,400 to reflect the amounts transferred to SS&T in the originally filed return.
