Accounts S-9, S-10, S-21, S-25, S-34, S-54, S-83, and S-104 are invested in The Southern Virginia Diocesan Foundation of The Episcopal Diocese of Southern Virginia. The Trust Department of Bank of America in Richmond, Virginia manages this fund. The Bank's accounts are audited and we feel this is sufficient. Monies received are forwarded quarterly to the Diocese with deposit instructions. Expense monies for maintenance and preservation of our church properties are withdrawn from S-34 (Income Account) quarterly and disbursed as approved by our Endowment Fund Board. We still have no information as to value.
