Travel grants are awarded to newly selected junior fellows in order to participate in an introductory meeting to learn more about the Melton Foundation and what expectations the foundation has of the new fellows. In 2011, the meeting was held in Heidelberg, Germany.

The cost of hosting the annual symposium in Temuco, Chile where all the Melton foundation Fellows (students and alumni), certain faculty and guest speakers were invited to participate and give presentations. Presentations included cultural performances and presentations as well as theme oriented presentations such as innovative, environmental social services and educational presentations and projects.
