Not Alone Program This program targets fatherless households in Egypt at the lowest socio-economic levels by supporting children's educational progress as a cornerstone in breaking the cycle of poverty. Not Alone also provides access to basic rights and empowers children to become change makers by addressing both immediate and long-term needs. Holistic development is key as each participant is encouraged and supported to develop academically, socially, and emotionally. In 2011, Not Alone continued to focus on development with a focus on living (universal) values. Around 298 workshops were conducted for children and 116 workshops conducted for mothers on the value of cooperation, honesty, and leadership.

Valuable Girl Project The Valuable Girl Project focuses on high poverty areas of Egypt where girls of all ages face a high risk of dropping out of school due to poverty and biased against girls. The Valuable Girl Project is to promote positive self-esteem practices among girls and young women between the ages of six and twenty-two who are at risk of dropping out of school. The promotion of positive self esteem practices will result in academic retention and access to basic rights.

Service to Learn Coptic Orphans connects youth from around the globe to Egypt. Volunteers travel to Egypt and spend three weeks during the summer to conduct activities in English, in a classroom setting, for the children in the communities they serve. In addition, they visit the homes of families of the fatherless children they interact with during the day. In 2011, Coptics Orphans facilitated placements for 6 volunteers from the United States of America.
