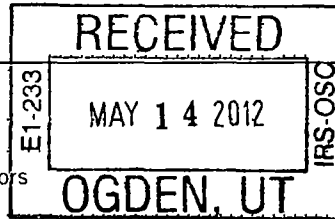

Dr. Buzz Aldrin took several trips to meet with NASA officials and other space organizations to further promote the future of the space program and to promote his ideas of commercializing space travel. Dr. Aldrin also participated in a Human Spaceflight Forum.
