ECONOMY AND THE POTENTIAL CHANGES TO BRAZILIAN LAW REGARDING SET-ASIDES FOR FOREST CONSERVATION ACT PROVIDED THE SURUI WITH VITAL RESOURCES NEEDED TO IMPLEMENT THEIR VIGILANCE PLAN IN 2011, ENABLING THEM TO SAFEGUARD THEIR FOREST HOME UNTIL REDD (CARBON CREDIT) PAYMENTS BECOME AVAILABLE THROUGH THEIR CARBON PROJECT, THE SURUI ARE SETTING THE STANDARD FOR ALL FUTURE COMMUNITY REDD PROJECTS IN OF THE SURUI PEOPLE TO PLAN AND IMPLEMENT FOUR VIGILANCE EXPEDITIONS SO THAT THEY COULD DETECT AND RESPOND TO THREATS IN AND AROUND THEIR 612,000-ACRE RESERVE IN A TIMELY FASHION THE EXPEDITIONS WERE CARRIED OUT IN COLLABORATION WITH THE BRAZILIAN GOVERNMENT’S NATIONAL INDIGENOUS AFFAIRS AGENCY ALL THE WAY THROUGH TO THE LIMITS OF THEIR 612,000-ACRE RESERVE DURING THESE EXPEDITIONS, THE GUARDS IDENTIFIED RENEWED LOGGING IN ONE OF THEIR VILLAGE AREAS, BRINGING THIS ACTIVITY TO A HALT HAS BEEN THE FOCAL POINT OF THE SURUI TEAM’S RECENT EFFORTS IN BRAZIL, IN PARTNERSHIP WITH KANINDE, ACT HELPED THE JIAHUI INDIGENOUS PEOPLE OF AMAZONAS STATE DRAFT A MANAGEMENT PLAN FOR THEIR LANDS BASED ON DETAILED ETHNO-ENVIRONMENTAL SURVEYS IN BRAZIL, IN PARA STATE, ACT PARTNERED WITH A RANGE OF PROMINENT BRAZILIAN STATE INSTITUTIONS, INCLUDING THE ENVIRONMENTAL ENFORCEMENT AGENCY, TO CONDUCT AN EIGHTH STATE INSTITUTIONAL PARK GUARD TRAINING COURSE, BUILDING THE CAPACITY OF REPRESENTATIVES OF A WIDE VARIETY OF AGENCIES AND ORGANIZATIONS TO HELP MONITOR PROTECTED AREAS IN BRAZIL, TO HELP POSITION COMMUNITIES OF THE TEN-MILLION-ACRE TUMUCUMAQUE INDIGENOUS RESERVE TO OBTAIN SUSTAINABLE ONGOING FINDINGS, ACT IS HELPING THE LOCAL TRIO INDIGENOUS COMMUNITY DEVELOP A SUSTAINABLE MANAGEMENT PLAN FOR THEIR LANDS IN SURINAME, ACT PROVIDED CONTINUOUS ASSISTANCE AND GUIDANCE TO THE WORK OF INDIGENOUS PARK GUARDS ACTIVE IN THE REMOTE INTERIOR VILLAGES OF KWAMALASAMUTU, TEPU, SIPALIWINI, AND APETINA, PROVIDING SUPPLIES AND LEADING THE GUARDS IN ENVIRONMENTAL MONITORING EXERCISES, INCLUDING WATER AND SOIL QUALITY TESTING USING STANDARDIZED KITS ACT ALSO IS ENABLING THE CONTINUOUS TRAINING OF THE INDIGENOUS PARK GUARD GROUP OF KWAMALASAMUTU IN COMPUTER SKILLS TOWARD ENVIRONMENTAL MONITORING AND REPORTING CAPACITY, AVERAGING SEVEN LESSONS PER MONTH WITH NINE PARTICIPANTS ADDITIONALLY, ACT COMPLETED CONSTRUCTION OF GUARD POSTS FOR THE INDIGENOUS PARK GUARDS OF THE INTERIOR VILLAGES OF TEPU AND SIPALIWINI, AND CARRIED OUT NECESSARY MAINTENANCE FOR THE PREVIOUSLY ESTABLISHED KWAMALASAMUTU POST, INCLUDING SUPPORTING INTERNET FACILITIES AND SATELLITE DISH
